Broker Age General Insurance Inc. is the owner of the information, which is collected on this website. We will not sell, disseminate, disclose, trade, transmit, transfer, share, lease or rent any personally identifiable information to any third party not specifically authorized by you to receive your information except as we have disclosed to you in this Privacy Policy.

Information Collection

We will ask you to provide your personal information to us when you apply for and purchase an insurance policy from us. We will confirm your consent by having you review and sign a 'Personal Information Consent' form.

We will ask you to provide your personal information to us if you e-mail us from this website. When you request quotes, apply for insurance, or purchase an insurance policy at Broker Age General Insurance Inc., we will ask you to provide your name, home address, mailing address, telephone number and e-mail address, as well as all particulars regarding the subject of insurance that are required to obtain quotes on your behalf.

This information will be provided to the insurance company when you purchase an insurance policy so they can establish you as a policyholder. We will maintain a record of your information at the offices of Broker Age General Insurance Inc. so we can provide you with policyholder service.

The employees of Broker Age General Insurance Inc. are each required to sign, acknowledge, and agree to a Confidentiality and Non-Disclosure Agreement which is part of their employment contract. Each employee has been instructed on maintaining the privacy of each customer and the importance of protecting the customer's personal information.

When you purchase an insurance policy from Broker Age General Insurance Inc., you will pay the premiums via:

- Credit Card.
- Personal Cheque
- E-Transfer
- Debit Card
- Authorized Monthly Withdrawals from your bank account.

Information and/or a record for these payment methods may be retained electronically on a secured, private database in our office or by the insurance company you are placed with.

When you send us an e-mail from this Web site, you will provide us with certain personally identifiable information including your e-mail address.

Cookies

A cookie is an electronic piece of data that is stored on a visitor's hard drive while they are visiting this website. We may utilize a short-lived form of cookie when you visit this site. At Broker Age General Insurance Inc., a cookie is only used to identify one unique visitor from another visitor during a particular session. A session is the period of active site-use while that unique visitor is linked to our server.
